Phone Upgrade

Brenda spoke to the board regarding upgrading the office phone system. The system is 18 years old, some of the jacks are not working and the wiring needs replaced.

Following discussion, the board would like Brenda to add it to the NMFA Loan for now and will discuss it again next month.

Interagency Agreement with Ciudad SWCD

Brenda discussed the Interagency Agreement with Ciudad SWCD. On July 7, 2025, Brenda and Steve Glass, Ciudad SWCD Chair, met with the Bernalillo County Assessor to determine mill levy collection for parcels within Ciudad SWCD boundaries that have historically paid Central Tri-County SWCD mill levy. Both parties agreed to keep this in place instead of reassigning the parcels described above to CSWCD for mill levy collection, since it may be confusing to the landowners. Both Steve and Brenda signed the map during the meeting with Bernalillo County on July 7th. This agreement is the formal paperwork for Bernalillo County.
